General comments	The United States welcomes the Country Programme Document for Senegal. • The only specific WASH interventions listed are Community-Led Total Sanitation (CLTS) (paragraph 16) and installing water points and latrines in schools (paragraph 22). Both of these approaches are known to have limitations in terms of long-term sustainability (as little as 1-2 years later in many cases). Are there approaches that UNICEF will implement that will focus on sustainability (i.e. operations & maintenance) of new and existing WASH infrastructure?

- UNICEF acknowledges and appreciates the comments on its draft country programme for 2024-28 from the Government of the USA and welcomes the opportunity to provide additional information that could not be adequately covered in a document of 6000 words.
- UNICEF CO in Senegal recognizes the importance of sustainability of new and existing WASH infrastructure in schools.
- UNICEF CO in Senegal plays a key role as convenor of all parties involved in the sanitation and WASH in schools, collaborating with communities, NGOs, regional technical departments and respective line Ministries. By strengthening capacities at all levels and ensuring close monitoring of WASH service functionality, UNICEF contributes to improving the sustainability of WASH services.
- The CLTS approach remains an efficient entry point for improving the situation of sanitation in communities. In the new Country Programme, it is envisaged that the CLTS approach will be complemented with support from the private sector, to achieve sustainable access to improved sanitation
- In addition, UNICEF CO in Senegal and partners will keep a strong footprint in communities to monitor the sustainability of the CLTS gains.
- Furthermore, as part of UNICEF's engagement in public financing for children, leveraging sustainable

	domestic resources for sanitation scale-up will remain a priority in Senegal.
	The key interventions related to the sustainability of WASH infrastructure will be included in a more detailed workplan starting in 2024.
