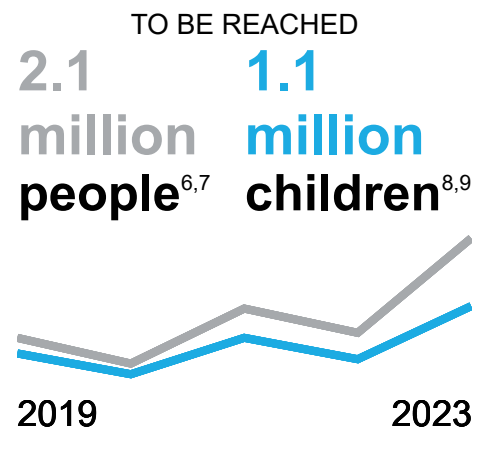
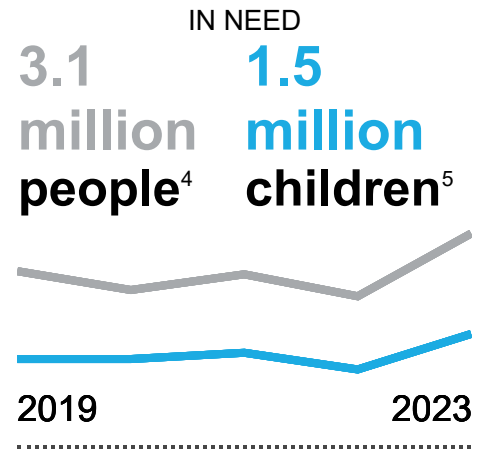

HIGHLIGHTS¹

- Since 7 October, the conflict escalation has led to grave humanitarian consequences including the reported loss of thousands of children and women, along with soaring humanitarian needs and an estimated 160 children being born every day under precarious circumstances.²
- 1.5 million internally displaced persons, over 60 per cent of the Gazan population, face an increasingly dire humanitarian situation with limited access to basic needs such as water, electricity and health services.³
- UNICEF is delivering immediate life-saving humanitarian assistance in the Gaza Strip to support conflict-affected and displaced people. Services are being supported through supply delivery, partners and remote service provision. In the West Bank, including East Jerusalem, UNICEF is scaling up humanitarian preparedness and is responding to immediate needs.
- UNICEF requires US\$154.4 million to respond to the humanitarian situation in the State of Palestine, this funding will support the continuation of gender-responsive WASH, health, child protection and education services in the Gaza Strip and the West Bank as well as the provision of multi-purpose cash assistance.

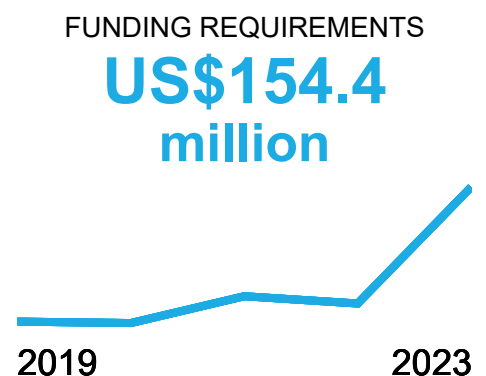

HUMANITARIAN SITUATION AND NEEDS

There are an estimated 3.1 million people requiring humanitarian assistance in the State of Palestine, with 2.2 million in the Gaza Strip and 900,000 in the West Bank.¹⁰ The Gaza Strip has tragically witnessed the loss of thousands of children and women, and the escalation which began on 7 October compounds the protracted protection crisis.

Following intensive bombardments, the Ministry of Health (MoH) has reported that as of 1 November 8,805 Palestinians, including 3,650 children, have been killed in the Gaza Strip since the start of hostilities which has resulted in an estimated increase of more than 1,862 new female-headed households. A further 22,240 Palestinians are reportedly injured, including 7,468 children.^{11,12} The situation of internally displaced people is dire, with an estimated 1.5 million IDPs residing in UNRWA shelters, hospitals, public buildings, non-UNRWA schools, and with host families.¹³

The Gaza Strip has been grappling with an almost complete electricity blackout. According to the Palestinian Water Authority, the current water production capacity has been reduced to 5 per cent of the normal daily production, limiting access to WASH services specifically for children and adolescent girls. Insufficient access to water compels the population to use unsafe water, potentially leading to additional health issues. According to WHO, there have been 93 attacks on health care in the Gaza Strip since October 7, with a further 123 attacks in the West Bank.¹⁴ Critical gaps in access to health services particularly affect adolescent girls and women, including emergency obstetric care, newborn care, and sexual and reproductive health services. Pre-conflict the State of Palestine had a high burden of mental health issues, and WHO report that there are over 485,000 people, including children, with severe or moderate mental health disorders in the Gaza Strip. Since the escalation 625,000 children enrolled in school across the Gaza Strip have had no access to education, with 246 attacks on school buildings since 7 October.

The West Bank, including East Jerusalem, is also facing increased violence, particularly in the context of Israeli forces operations and resulting confrontations. As of 1 November, at least 130 Palestinians have been reported killed since October 7, including 40 children. Access restrictions have been imposed throughout the West Bank, including East Jerusalem, isolating Palestinian communities and severely limiting their access to essential services. In the West Bank schools have also been heavily affected by movement restrictions, military operations and settler violence.

Israeli authorities' sources report that at least 1,400 Israelis have been killed, and according to Israeli authorities, 240 Israelis were abducted into the Gaza Strip, including around 30 children.

STORY FROM THE FIELD



Due to the escalation water scarcity is a grave concern in the Gaza Strip where it is estimated that people have had access to less than three litres of water per person per day, far below the minimum emergency threshold of 15 litres. This poses a health risk in a densely populated area, with adolescent girls and pregnant women being specifically affected. A resident in a shelter for displaced people said: "We do not have anything here, we suffer from insufficient water, clothes and food, we are trying to cook anything for our children, the situation here is really devastating."

Following the activation of the Inter-Agency Contingency Plans both in the Gaza Strip and the West Bank, UNICEF with partners is delivering immediate lifesaving responses in the Gaza Strip, and scaling up humanitarian preparedness and response in the West Bank including East Jerusalem.

In the Gaza Strip, the priority areas are WASH, Health and Child Protection services. UNICEF is also scaling up the provision of nutritional screening and treatment and recreational and learning activities for conflict affected children. UNICEF is coordinating closely with a wide range of partners to scale up gender responsive humanitarian responses to meet immediate life-saving needs, and other basic needs, and to preserve human dignity for conflict-affected children, their families and communities. Given access constraints and insecurity UNICEF is utilizing a range of programme delivery strategies including supporting the existing health, water and sanitation systems; cross-border emergency supply delivery from Egypt to implementation sites; humanitarian cash transfers; social and behaviour change; and remote service provision. Partners including NGOs and women-led organizations within the Gaza Strip, are also mobilized to support emergency programme delivery.

For the West Bank, UNICEF is scaling up humanitarian preparedness and response through existing and expanded partnerships and supplies pre-positioned in the West Bank. Further resources are being mobilized to be ready to respond to increasing humanitarian needs in the West Bank due to the escalation in the Gaza Strip.

Gender and disability considerations are prudently integrated across UNICEF humanitarian interventions including through integrating Gender Based Violence into child protection case management and through partnership with women-led and girls-centered organisations. A tailored Adolescent Girl Humanitarian Package is also being rolled out and UNICEF supports the Inter-Agency Network for the Prevention of Sexual Exploitation and Abuse (PSEA).

UNICEF is an active member of the UN Country Team and the Humanitarian Country Team and closely coordinates with other organizations including local partners. UNICEF also leads the coordination of the WASH Cluster and co-leads the Education Cluster with Save the Children. Within the Protection Cluster, UNICEF leads the Child Protection Area of Responsibility and participates in the GBV Area of Responsibility. UNICEF is part of the Inter-Cluster Mental Health and Psychosocial Support Technical Working Group. UNICEF co-leads the Nutrition Working Group within the Health Cluster. Towards Accountability to Affected Populations and PSEA UNICEF works closely with WFP and a national NGO to manage community feedback.

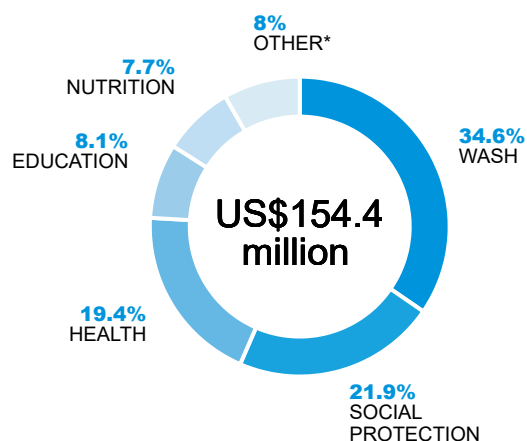

FUNDING REQUIREMENTS IN 2023

UNICEF has significantly increased the funding requirement to US\$154.4 million to respond to the immediate humanitarian needs in the State of Palestine. This funding will allow UNICEF to deliver gender-responsive immediate lifesaving and protection interventions for water, sanitation and hygiene; health; nutrition; child protection; multi-purpose cash; and education services.²¹

Humanitarian funding for 2024 will allow UNICEF to procure lifesaving supplies and support essential services. The funding needs are driven by the need to scale up humanitarian programming in the Gaza Strip due to the extensive and acute needs, as well as preparedness and response for the West Bank, considering the violence, unrest and increasingly volatile environment. Health, WASH, child protection, education and nutrition supplies will be procured and delivered through various channels including for the cross-border operation at the Rafah crossing in Egypt, and for pre-positioning within the West Bank.

Without this funding, UNICEF will not be able to support the immediate needs of the 2.1 million people (1.1 million children) nationally, including in the Gaza Strip where people are living with minimum quantities of water, with a health system on the verge of collapse, and whose children urgently need mental health and psychosocial support. In addition, without this funding, UNICEF will not be able to establish preparedness and response for a worsening humanitarian situation facing children in the West Bank, including East Jerusalem.

The total number of people to be reached is calculated based on the following program targets: in the Gaza Strip, 1.8 million people provided with access to water; in the West Bank, 280,000 children to be reached through medical supplies and 42,000 pregnant and lactating women receiving iron supplementation. Gender disaggregation is 50.7% male, 49.3% female, and 2.1% people living with disability and difficulties, as per the 2017 Palestinian Census.
